Fundraising Report November 7, 2022

Fundraising has started! Though we did not end up with a volunteer volunteer, I have offered to oversee it generally, with various volunteers to run specific opportunities.

We still have lots of SaveOn and Thrifty grocery cards, and have ordered more QF (they are ready for pick up, we just need a cheque and picked up)

I am in communication with Mandeep from Panago to receive a new order of their Pizza coupons. The program has been updated, to fit into the rising cost of.....everything. They will be \$14 each, for a medium with unlimited toppings and an expiry date of 3 months. I was looking to order 50, possibly 75, if the club thinks they can sell that many. I believe the kick back is still \$4 per coupon sold.

West Coast Seeds has been applied for and I made sure to ask for an earlier time frame to order (now that I have learned a bit about gardening LOL). If approved, our campaign will run in late January, so the product should be here before Spring Break!

Currently Purdy's is still open until the 29th of November. We have currently only received \$398 in orders - remember, the more we order the more credit we get kicked back to us! Currently we are at about the 5% level. Thanks again to Christine for organizing this one!

Amanda is looking into a Cookie Dough fundraiser again this year - hopefully we can time it right (these things are really all about timing), so we will keep you posted as we learn more!

We will have the Swim-A-Thon in January, and aside from that we are still hoping to do the Movie Night (which will be a Club fundraiser - meaning all profits go directly to the Club) and at least one bottle drive this season. If there are other ideas families would like to organize, don't hesitate to reach out!
