## **ADDITIONAL NOTES:**

• Purchasing a club "gopro" might be worth the expense in order to capture underwater videos for team feedback and education. Or possibly a club iPad/tablet that could be waterproofed for underwater filming (currently Lisa is using her own personal iPad for filming).

- We need to get the RAC speaker fixed. It was noted that Sydney has a sound tech friend who might be able to help.
- Volunteer credits start this summer. This is a pilot year for this new fundraising/volunteer policy to see how it is received and if it generates improved club participation.
- Tentative Program Scheduling: Competitive will be coached by Lisa in the same time slot as previous year. Some of the AquaGo! Group will be moving up to Limited Comp 5-6:30 with Tabi. Carol will coach AquaGo! 5:30-6:30, and Carol & Tabi will be available to Coach AquaGo! 6:30-7:30 if there is enough enrollment. Lisa will coach Masters in same time slot as previous year.
- Suggestion to ask BCAS if recorded meeting minutes is acceptable or not decided no, because we must have records to read over at meetings
- Suggested to plan a "start of season" meet & greet, or parent info night, possibly rent the pool for an hour? Or host a movie night (suggested "Mermaidia"). Or an end of summer, mid August/Sept pool party? Invite the public? Time it with the RDN rec guide?
- Possibly need to provide additional info to parents about the grocery card fundraiser as they were not used effectively this year. Great way to boost fundraising if taken advantage of.
- Note Society Act due mid October (need to have final names of board members before then)
- Pool reopens mid September-ish
- Year End BCAS meeting date is June 16th
- Carol will reach out to pools regarding scheduling for the next season
- Erin wondering about reaching out to the PQB News to see if the sports writer could cover the Jean Peters meet. We could also provide info about the qualifiers in Richmond and send pictures.
- Mark suggested getting a spot on the PQB Pod Cast page this summer to help promote as well
- A suggestion to apply for the RDN grant in September was made to put on a fun meet during the season; we could invite the Nanaimo Diamonds, and the Victoria club.
- Another suggestion for a fun event, at no cost, would be to have a 'Parents Learn Synchro' event and have the parents joining their athletes in the pool to learn what they do
